



## Filing for Homestead Exemption

The **Homestead Exemption** is available to legal residents of Georgia for their primary residence. **You are entitled to the Homestead exemption if you owned and occupied your home by January 1.** You are able to claim a partial exemption which can amount to **substantial property tax savings**. Senior citizens may have additional exemptions available - check with your county tax office. **Please note: The filing deadline for all counties is April 1.**

### **What You Need in Order to File:**

A copy of the recorded warranty deed, Social Security numbers of all persons on the deed, the mortgage holder, and the amount of the mortgage. **Note:** Some counties may require a copy of the closing statement and proof of age for senior citizens.
